### The latest

Bhewerre Wetland Stage 1 boardwalk construction has commenced and works to date include clearing of vegetation for the borardwalks, site compound set up and the installation of the piers for the accessible boardwalk along Cockcrow Creek, and the Viewing Platform. The piers for Alignment A are currently being installed to connect with Larmer Avenue.

## About the project

The boardwalks at Bherwerre Wetland, Sanctuary Point, is one of seven Sustainable Tourism Infrastructure Projects to improve infrastructure around some of the City's most popular tourist destinations. Council successfully obtained grant funding of \$5.3 Million under the NSW Government's Restart NSW Infrastructure Grant for the sustainable tourism infrastructure projects.

The funding has allowed for Stage 1 works only which is on the northern side of the canal. Local contractor GC Civil Pty Ltd are undertaking the construction of the Bherwerre Wetland Boardwalk Stage 1. The current contract will see the construction of an accessible carpark at the end of Park Drive, an accessible boardwalk (393m long x 2m wide) to a viewing platform at the junction of the canal and Cockrow Creek and a boardwalk from Larmer Avenue (420m long x 1.2m wide) to the proposed carpark. Signage and seating will also be included.

Further expansions of the boardwalk are planned for the southern side of the canal, which includes a bridge crossing, and will be implemented as budget becomes available.

The site will be closed during construction – refer to the Boardwalk Construction Stage 1. It is anticipated the boardwalks will be opened in mid-September.

Thank you for the newsletter.

We too have the school bus pull up twice every afternoon. We don't have kerb and guttering. My husband now has a mobility scooter and has to navigate across the gravel to the road, which also brings us to the ever ongoing problem of no footpaths in this area, from Greville Ave until you get to Kerry St.

I recently drove to Hyam's Beach and wow what improvements have been done there. Excellent concrete footpath and still being constructed. Undercover bbq area, new toilet block, new kids' playground.

As usual Sanctuary Point population as per Census 2021 was 7874 is treated as the poor cousin to the other areas around here.

Hyam's Beach population as per Census 2021 was 137.

Last week did the Basin walk from end of Frederick St left up to the wooden bridge which was burnt and Council cut out the burnt bits, then yesterday did the right side going right up to the drive to Walmer Ave which is opposite the old Barefoot Cafe.

No proper path along either side gravel only, wooden bridges and a couple of new composite grating bridges.

I don't think they are going to put the composite grating boardwalk along these walks which I find very sad.

I took photos along the way and also of Hyam's improvements and will be emailing Council.

That's my rant for today.

We, as directors, are acutely aware of our duty not to engage in operational matters, as this is the exclusive domain of management. The cautious policy of paying down debt and not taking speculative risks with members assets has proved to be very well received. Catering revenue at the Basin hit an amazing \$3.3 million of high quality meals, with the independent caterer at Vincentia also proving to be very popular indeed. Functions and events revenue came in at a substantial \$231,963.

# **Sanctuary Point Library Project Update**

Council is at an advanced stage of planning for the construction and delivery of the Sanctuary Point Regional Library.

The Development Application has been submitted and the next stage of the process is to consider the procurement and project management services for the construction phase.

Construction for the Sanctuary Point Library is likely to commence at the end of 2023.

Some highlight features that have been incorporated into the design are listed below:

- Roof Top Terrance where the ridge looks out over the basin and sea.
- Courtyard with a feature of native Palms.
- Public Art
- Bespoke feature lighting
- Dynamic Sunshades wrapping the entire external walls and incorporating public art.

Shoalhaven City Council has committed funding towards the design of a new Regional Library for the Bay and Basin area in Sanctuary Point.

The Sanctuary Point District Library will inject new life into the Sanctuary Point village by providing a hub of community activity; access to technology and information; a place for meeting, collaborating, connecting, studying; and access to business spaces, reader services and collections.

# **Criminal Justice System in NSW - Structure**

As shown in Figure A, the NSW criminal justice system consists of: Lower Courts The Local Court The Children's Court

**Higher Courts** The District Court The Supreme Court (including Court of Appeal)

The Local Court deals with most criminal charges against adult offenders. The Local Court also holds committal hearings for indictable criminal matters (more serious




Figure A. Criminal jurisdiction in NSW

offences). Some indictable matters may be determined by the Local Court if the defendant so elects. The Children's Court deals mainly with juvenile offenders (aged 10-17 years). In some circumstances, charges against offenders aged 18 years or over may also be heard before the Children's Court. Local and Children's Court proceedings are conducted by a magistrate. There are no juries in these courts.

The District Court deals with more serious offences committed by both juveniles and adults. District Court proceedings are presided over by a District Court Judge. The District Court hears trials, sentencing matters and appeals against decisions made in the Lower Courts. In most cases where the accused person pleads not guilty, trials are held before a judge and jury. In certain circumstances the accused may elect to be tried before a judge alone. If the jury delivers a verdict of guilt, the judge determines an appropriate penalty. When a person admits guilt there is no jury trial and the matter proceeds to sentencing.

The Supreme Court conducts trials before a judge and jury for a few offences which are more serious than those heard in the District Court, such as murder. As in the District Court, in certain circumstances the accused may elect to be tried by a judge alone. The Supreme Court may also deal (without a jury) with certain offences which carry very heavy fines (e.g. water or air pollution offences). The proceedings are presided over by a Supreme Court Judge.

The Court of Criminal Appeal, which is a special division of the Supreme Court, hears appeals against convictions and/or sentences from the District Court and from the Supreme Court. An appeal is conducted in the presence of three Supreme Court Judges. The Court of Criminal Appeal is the ultimate court of appeal for criminal matters in NSW.

As an alternative to entering the court system, juveniles charged with relatively minor offences may be dealt with by a system of formal police cautions. A caution is issued by a senior police officer in the


presence of the offender and his/her parent or
