#### The latest

15/06/2023 - During pavement remediation, Council encountered very soft and saturated clay (subgrade) material, resulting in subsoil drainage being installed on either side of the road. As a result of these additional works, completion is now scheduled for early July 2023.



#### **About the works**

07/06/2023 - Works are currently underway with an expected completion date of 16 June 2023, weather permitting. During this time, the road will be closed during daylight hours with resident access only and a detour in place.

# OPPOSITION CALL ON GOVERNMENT TO ANSWER KEY QUESTIONS

The Opposition has called on the Premier and the Police Minister to provide a full explanation of the many inconsistencies and gaps that have emerged since the community first learned about the tasering of a 95-year-old grandmother.

The Opposition have given notice in Parliament today calling on the Government to release communications between the Premier, Minister for Police, NSW Police and public officials that were being exchanged at the time.

Leader of the Opposition Mark Speakman said, "today in Question Time the Police Minister deflected, dissembled and refused to answer direct questions about her actions as the Minister".

"The Police Minister has repeatedly failed to provide any transparency and give the public any confidence that she is on top of this situation or her portfolio," said Mr Speakman.

"Her Excellency the Governor told police graduates last week that 'public trust in the police serves as the bedrock of its legitimacy'. However, the Police Minister is currently undermining that trust by failing to exercise her responsibilities as Minister as she continues to avoid questions and any scrutiny into her actions," said Shadow Police Minister Paul Toole.

The Government must immediately answer the following questions:

- 1. **If the Police Minister's** explanation for why it took so long to inform the public is that the family needed to be told, why did it take a further 19 hours after the family met the Critical Incident Team before a release about the use of a taser was issued?
- 2. Why did the Minister mislead the public and Parliament by failing to share this information?
- 3. Had the aged care facility or the police already informed the family of the incident before the meeting with the Critical Incident Team? If so, when did the Minister and police know this and why was the use of a taser not then disclosed to the public?
- 4. As the Minister has admitted to being briefed about the incident on 17 May, why did she ignore her duty to correct the public record when the police media release stated that no further information was available?
- 5. What efforts did the Minister make to keep herself up to date with developments after the original briefing on 17 May?
- 6. When did the Minister know the family had been informed? What steps did she take or what enquiries did she make after that, to ensure the public were told as soon as possible?
- 7. What knowledge did the Premier and his office have, and what role did they play, in communications to the public about the incident?

#### Resource recovery facility project update

PUBLISHED ON 26 JUNE 2023



Options for the delivery of a resource recovery facility that diverts the maximum amount of resources from landfill, will soon be considered by Council.

Council is working through contractual issues involved in its agreement with Bioelektra Australia, who had been contracted to build and operate the facility before it went into liquidation on 15 June 2023.

While the legal process could take a number of months, it is an important part of Council's ongoing due diligence in respect to this project.

"Whatever the outcome of the legal process, we want to ensure that we use the best option available to us to divert the greatest amount of waste from landfill," said Mayor Amanda Findley.

"Council is recognised as a leader in the waste management field and has won multiple awards for innovation and showing initiative in recycling and reuse," Cr Findley said.

"I'm confident that we can stay the course of finding the most suitable and efficient technologies available that will provide the best outcomes for our communities today and in the future," she said.

Waste processing is continuing as usual with no disruption to kerbside collection services or waste management across the Shoalhaven LGA.



### IMPORTANT INFORMATION FOR CLUB MEMBERS

This club is by law required to keep a register containing information that relates to the management and financial administration of the club including:


#### **Email sent to Shoalhaven Council Maintenance Department on the 9th** May 2023 as follows

Sanctuary Point.

My wife and I have no complaints about the children being picked up, it is just the deep holes the bus makes in front of our drive when the bus arrives and in front of our verge when it leaves.

The main fault is the unkempt shoulder of the road, which is impeded by the lack of drainage in Ridgelands Drive and the blockage from the Grass and soil that is not main-



We have always maintained the verge in front of our place in a respectable condition and try to keep the shoulder free from blockages to take the water away. Without proper maintenance from council on the shoulder we find it difficult to have a clean enter and exit when we use our vehicles and the heavy load of the bus keeps on making large holes in the shoulder, as you can see from the photos provided.

#### 3.2. Scope of Councils Maintenance Activities

# An evaluation of Local Coordinated Multiagency offender management

An evaluation of Local Coordinated Multiagency offender management

The Bureau of Crime Statistics and Research (BOCSAR) has released an evaluation of the program *Local Coordinated Multiagency (LCM) offender management.* 

- LCM is a multiagency approach to offender management where the Department of
  Communities and Justice, the NSW Police Force and NSW Health work in partnership to
  provide tailored case management and wraparound support to offenders under
  Community Corrections supervision. Support may include referrals to housing services,
  disability services, health and mental health services, drug and alcohol services, victim
  services, and relationship services in addition to any rehabilitation programs.
- The evaluation considered whether LCM participation was associated with changes in
   various forms of reoffending or 2. return to custody.

The evaluation found no association between participation in the program and any measure of reoffending reduction when comparing LCM offenders to a matched comparison group. The results also suggest a 10 percentage point increase in the likelihood of returning to custody within 12 months among LCM participants. Results are limited, however, by our inability to identify a comparison group of offenders who have multiagency needs.
