

My SAY!

There were three hundred (300) copies of my first Newsletter printed and distributed around Sanctuary Point. A further e-mail with a covering letter and my Newsletter was sent to Mrs Joanna Gash MP Federal Parliament, Mrs Shelley Hancock MP State Parliament, Clr. Paul Green Shoalhaven City Mayor and our eight (8) Councillors, Sanctuary Point's boundary is split between Ward 2 and Ward 3. Although! I did not receive a reply from all of the recipients of my email, I did receive a reply from both, Federal and State Members of Parliament and four of the Ward 2 and 3 Councillors, Watson, Proudfoot, Miller and Fergusson with their promising assurances, that they would try to make changes for our town Sanctuary Point. (I had no reply from the Mayor and four of the Councillors) That's OK, they are probably very busy on more important matters ... Thank you for those who did reply, I will rely twice as much on YOU!

My Wife and I distributed a copy of the first issue, in the early morning of Friday 18th February 2011 to every business establishment we could find in Sanctuary Point, if we could not deliver by hand, it went under their door or in some appropriate location they could easily see when they opened up their business. The remaining copies were scattered around the residents of Sanctuary Point.

I approached the Huskisson Police Station on Monday 21st February 2011 and gave two copies of my February 2011 Newsletter to a Senior Constable. Having heard that her Officer in charge, Sergeant Wes Hanrahan, had been admitted to St George Hospital in Sydney, for surgery on his already, hazards of the job, scarred face. I heard later that a further 14 stitches have been inserted in his face ... may I say! very respectfully, to a dedicated, brave Policeman ... I salute you and wish you a speedy recovery from the dog attack and the injuries that you received.

When I compose these Newsletters, you would wonder why I delete so many words that I write, it is so very hard to be non political and at times, I feel like delving into much more that what is said in this Newsletter, I also have other thoughts, other concerns and other ideas ... but! at the moment I will be non political and trust in those that have said they are on my side and will help to put things right in SANCTUARY POINT I can ask for no more, but trust them in their integrity, to help us to put things right, there are too many of your constituents that are believing that you are sincere ... please ... don't let us down.

You know and they know, that <u>NONE</u> of my concerns have been fully addressed ... and that means! I know also ... but!
