To provide basic information to citizens, who are trying to ... help our Local Community, to help Them! To Help Us!

Even so! I have decided to include the following information, within my Newsletter, as a **community service**, instead of a bipartisan agreement between our Local Police Force and the small contribution, that my Newsletter was hoped to contribute.

It will be recorded as an Incident and passed on to the appropriate Police Station to follow up ... It will also become a Statistic and they can be used for the allocation of Police in your Local Police Precincts.

or CRIME STOPPERS call 1800 333 000

Remember ... If you want to stop Crime ... I mean ... You really want to stop Crime ... Commit yourself to a SIGNED STATEMENT and you will REALLY give your POLICE something to WORK WITH!
